IP&E Holding, LLC. dba: IP&E Guam inquiry dated 03/13/18:

QUESTION:

1. Section 4 of the contract's volume specifications references DES (Delivered Ex-Ship) provisions. In lieu of DES, please advise if the contractor may likewise supply the diesel fuel via tank-to-tank transfer from stock already on-shore. This requested option would alleviate GPA notice lead time and allows the contractor to provide fuel immediately if available on-shore.

ANSWER:

Amendment to the bid package will be forthcoming to reflect the changes to Section 4 of the contract and other parts of the bid specification.

ExxonMobil Asia Pacific Pte. Ltd. inquiry dated 03/03/18:

QUESTION:

1. When would the amendment to this bid (GPA-008-18) be made as GPA has determined the bid for Diesel Fuel Oil No. 2 delivery services (GPA-006-18) cancelled?

ANSWER:

Amendment to GPA-008-18 the bid package will be forthcoming to reflect the changes to the bid specification.

QUESTION:

2. Would GPA confirm if the loading rack available at Tristar is top or bottom loading?

ANSWER:

Loading rack at Tristar is bottom loading. However, amendment to GPA-008-18 will be forthcoming to reflect the changes to the bid specification that will require Contractor to utilize its own loading rack facility.

QUESTION:

3. Would GPA confirm if all Diesel Fuel No. 2 will be loaded out of Tristar terminal?

ANSWER:

Amendment to GPA-008-18 will be forthcoming to reflect the changes to the bid specification that will require Contractor to load and deliver utilizing its own loading rack facility.

All other Terms and Conditions in the bid package shall remain unchanged and in full force.
