#### **INVITATION TO BID**

The Government of Guam, through the Guam Power Authority, is soliciting bids for the **GPA Renovation and Upgrade of Executive Offices at the Gloria B. Nelson Public Service Building (Design-Build).** Interested parties are required to submit two (2) copies and one (1) original of their sealed bids to the Guam Power Authority, Procurement Office located at 688 Route 15, Mangilao, Guam no later than <u>2:00 P.M., Wednesday, April 19, 2017</u>. Bids will be publicly opened in the Procurement Conference Room, 1<sup>st</sup> Floor, Gloria B. Nelson Public Service Building, 688 Route 15, Mangilao, Guam.

Contract time is <u>90</u> calendar days after issuance of Notice to Proceed. All bids must be accompanied by a bid security in the amount of 15% of the total bid amount. Bid security can be made by a surety bond or cash deposit in the form of a certified check or cashier's check made payable to the Guam Power Authority.

All interested parties are hereby notice that minority business enterprises will be afforded full opportunity to submit bids in response to the invitation and will not be discriminated against on the grounds of race, color and national origin in consideration for an award.

The right is reserved to reject any or all bids and to waive any imperfection in the bids in the interest of the Guam Power Authority.

A pre-bid conference (non-mandatory) will be held on <u>9:30 A.M., Thursday, April 06, 2017</u> at the GPA Procurement Conference Room 1<sup>st</sup> floor, Gloria B. Nelson Public Service Building, Mangilao, Guam. An investigation to allow prospective bidders to familiarize themselves with said project will be conducted after the pre-bid conference.
