INVITATION TO BID

The Government of Guam, through the Guam Power Authority, is soliciting bids for the **GPA UPGRADE** and **REPAIR** of the **CABRAS COMPOUND** and **SUBSTATION SECURITY FENCE.** Interested parties are required to submit two (2) copies and one (1) original of their sealed bids to the Guam Power Authority, Procurement Office located at 1911 Route 16, Harmon, Guam no later than <u>2:00 PM., July 17, 2014</u>. Bids will be publicly opened in the Procurement Conference Room, 1st Floor, GPA Central Building, 1911 Route 16, Harmon, Guam.

Contract time is **60 calendar days** after issuance of Notice to Proceed. All bids must be accompanied by a bid security in the amount of 15% of the total bid amount. Bid security can be made by a surety bond or cash deposit in the form of a certified check or cashier's check made payable to the Guam Power Authority.

All interested parties are hereby notice that minority business enterprises will be afforded full opportunity to submit bids in response to the invitation and will not be discriminated against on the grounds of race, color and national origin in consideration for an award.

The right is reserved to reject any or all bids and to waive any imperfection in the bids in the interest of the Guam Power Authority.

A mandatory pre-bid conference / site visit will be held on <u>July 09, 2014 at 9:00 A.M.</u> at the GPA Procurement Conference Room 1st floor, GPA Central Building, Harmon, Guam. An investigation to allow prospective bidders to familiarize themselves with said project will be conducted after the pre-bid conference.
