QUESTION:

1. Requirements for submitting a Statement of Interest.

The Guam Power Authority is seeking a Solicitation of Interest from interested vendors/contractors for the Bulk Supply of Ultra-Low Sulfur Diesel (ULSD) meeting the quality requirements listed in Exhibit A. Annual quantity may range from 500,000 to 1,000,000 barrels.
