## About us

- Tristar operates 48 fuel farms worldwide for the storage and handling of petroleum products with a total capacity of 683 million liters for handling a wide range of petroleum products like Jet Fuel, Gasoline, Gasoil, and Fuel Oil. Tristar's fuel farm network consists of storage depot constructed and operated in the services of international organization and the fuel farm in the Pacific Island of Guam.
- Our Guam fuel farm, spread over 237 acres, is one of the largest single storage fuel farms in Guam and the neighboring regions. Our Guam fuel farm consists of 26 tanks, with capacity ranging from 1,000 to 500,000 thousand barrels with a total capacity of 4.2 million barrels and is connected to an oil jetty within the Port Authority of Guam by means of an 8 kilometers pipeline

## Facility Access

All visitors are required to proceed to security guard office located at the main gate and present any government issued identification then sign visitor's logbook. The security on duty will issue Visitor's/Contractor pass identification and must be wear at all time inside the facility. Upon completion of your visit you must return issued Visitor/Contractor pass upon exiting the facility.

## Terminal Operating hours

Tristar normal operating hours is 0800-1700 hours Monday-Fridays except holidays. Facility is manned 24 hours, 7 days a week. Should you planned visit after normal operating hours you must send 24 hours notification and get an approval from Facility Security Officer (FSO) David Junior Quitugua thru (671) 565 3307/ (671) 727 3338 or email @ dj\_quitugua@tristar-guam.com.

## Personal Protective Equipment

All personnel entering the facility both Agat terminal and F1 dock facility, other than administration building, parking areas, safe walkways between offices, parking areas and satellite offices are required to wear high visibility vest, head protection, eye protection, safety footwear and coverall or long sleeves and pants. Safety footwear is not a requirement if the visitor has no intention of going out from the vehicle.
